**ORDER**

1. The present Application has been filed with the following prayer:

*Replace the Interim Resolution Professional, Shri Ravindra Beleyur (IBBI Registration No. IBBI/IPA-002/IP-N00082/2017-18/10162) and appoint Shri Prakash V. Kukreja, (Registration No. IBBI/IPA-001/IP-P-02599/2021-2022/13990), as the Resolution Professional of the Corporate Debtor in terms of the resolution passed in its 2<sup>nd</sup> CoC meeting dated 14.06.2025 read with the provisions of the*

*Insolvency and Bankruptcy Code, 2016 and regulations framed thereunder;*

2. Corporate Insolvency Resolution Process (CIRP) was admitted against the Corporate Debtor vide order dated 22.04.2025. The Committee of Creditors (CoC) was constituted by the Interim Resolution Professional (IRP) on 17.05.2025. In the first CoC meeting held on 23.05.2025, one of the agendas was the appointment of the IRP as Resolution Professional (RP), wherein 99.76% of the CoC has voted against his appointment.
3. In the 2<sup>nd</sup> CoC meeting held on 14.06.2025, the resolution for appointment of Shri. Prakash V. Kukreja as resolution professional, replacing Shri. Ravindra Beleyur was passed with 100% voting share. Moreover, it was decided that the Applicant herein would file an application before this Tribunal for replacement of the IRP on behalf of the CoC. Copy of the minutes of the 2<sup>nd</sup> CoC meeting and e-voting result is marked as *Annexure F & G respectively*. The written consent given by Shri. Prakash V. Kukreja is marked as *Annexure H*.
4. The Interim Resolution Professional present in court contended that he has not done anything against the interest of corporate debtor or the Creditors and there are no allegations regarding trust issues against him. He therefore has no say qua the application except that his fee & charges incurred during the process needs to be cleared.
5. Since the CoC has the freedom to have a IRP/RP of their choice under the scheme of Insolvency & Bankruptcy Code,2016 and a unanimous decision to replace the IRP has been taken, we **hereby allow the instant I.A.** and appoint **Shri. Prakash V. Kukreja** having registration No. IBBI/IPA-001/IP-P02599/2021-22/13990 having valid AFA till 30.06.2026 (*kukrejavprakash@gmail.com*)as Interim Resolution Professional of the Corporate Debtor, in place of Shri. Ravindra Beleyur. Let a copy of this order and order dated 22.04.2025 be forwarded to him to do the needful.





6. Mr Beleyur shall handover the control, charge and records of CD etc during his assignment, to the new IRP against receipt.
7. The CoC is obligated to make payment of balance fee & incurred charges during CIRP thus far to the erstwhile IRP. Let the **needful be done within two weeks here from.**
8. We expect the new IRP to make a considered decision in respect of IAs filed by the erstwhile IRP and pending disposal.
9. Accordingly, **I.A. No. 526/2025 stands disposed of.**
