It is clarified that the inclusion of names in this provisional list does not give any right to any of the aforesaid Prospective Resolution Applicants to be considered as part of the final list to be issued under Regulations 36A (12) of the CIRP Regulations. The Resolution Professional in terms of Regulation 36A (9) is still in process of reviewing the EOI documents submitted by the PRAs and has sought relevant clarifications / additional information / supporting documents from PRAs for conducting the due diligence on their eligibility and other requirements, as specified in the Invitation for Expression of Interest. In case of non-receipt of requisite clarifications/additional information/supporting documents, such PRA may not be considered in the final list.

In terms of Regulation 36A (11) of the CIRP Regulations, if anyone has any objection to the inclusion or exclusion of a Prospective Resolution Applicant in the provisional list as provided above, then such objections may be made with supporting documents within five (5) days of issue of the provisional list, i.e., on or before 24th November 2025. If any objections are received, then the Resolution Professional shall in terms of Regulation 36A (12) of the CIRP Regulations, in good faith, consider the objections and shall endeavour to issue final list of prospective resolution applicants within ten (10) days of the last date of receipt of objections.

It is clarified further that this provisional list of the eligible PRAs has been issued by the Resolution Professional after forming a *prima facie* opinion on the basis of the information / documents shared by the PRAs, and it is clarified that the undersigned reserves the right to conduct detailed due diligence on eligibility of the PRAs at any time. Please note that the objections should be sent by way of an email to sterneindia.cirp@gmail.com.

Notes:

1. The eligibility of any person or any other person acting jointly or in concert with such person to be the Resolution Applicant (“RA”) will be subject to fulfilment of conditions / criteria specified under section 29A of the IBC 2016 (“Code”) at the stage of submissions of Resolution Plan.
2. A PRA has to continue to be eligible under section 29A of the Code at the time of submission of the Resolution Plan as well.
3. The RP may seek any clarification or additional information or document from the PRA under Regulations 36A (9) of the CIRP Regulations.
