3. The Eligible PRAs in the final list are required to submit the Resolution plan on or before 08<sup>th</sup> January 2026 in prescribed manner as mentioned in the Request for Resolution Plan (RFRP), which will be circulated on 9<sup>th</sup> December 2025.
